ADDRESS THE IMPACTS WITH THE BOARD ON CERTAIN ISSUES LIKE THE VEGETATION ISSUE ON THE CORNER. MAKE THE PROPER PHONE CALLS AND CONTACT THE ENTITY THAT CAN HELP YOU CONTROL THE SITUATION. GO GET THE INFORMATION YOU NEED TO HAVE AND TAKE CONTROL OF THE SITUATIONS YOU THINK YOU HAVE NO CONTROL OVER. THE BOARD DOES NOT DICTATE YOUR APPLICATION.
