OTHER BUSINESS

- Village Attorney Matt Fuller gave a report on the new cannabis dispensary laws in New York State. The Village will need to decide whether to opt out, because if you don't, you will not be able to opt back in. It is the feeling of the Village Board that retail sales are a possibility but not allowing on site consumption. Motion by Trustee Boucher to hold a public hearing on November 1, 2021, at 6:45PM to adopt the resolution and local law regarding the Cannabis On-Site Consumption Licensing. SECONDED BY Trustee Carpenter. All Ayes. Motion Carried.
- The proposed sale of Church Street to Irving Tissue is still pending. There are still some minor issues that must be finalized such as the location of the sewer, water, and gas lines. The curbing will have to be installed and landscaping completed.

- > There is no update on the sale of the Fort Edward High School Annex to the Village. Will update when more information becomes available.
- Trustee Boucher inquired about the status of the River Street bank. Jeff Caprood said that Chazen Enterpries have been notified and they have been to the site. They recommend putting survey points up and monitor any possible erosion over the next few months. Will update when more information becomes available.
- Trustee Williams reported that the parking lot next to the old One More Grill is finished. He thanked the Village Street Department, Trustee Boucher, and Mike Dickinson from the Canal Street Marketplace for all their work. There are lights there which make the parking lot more accessible. We will consider getting signage so that people are aware that this is a Village parking lot.
- ➤ Gary Hill reported that the forestry from last year went extremely well. He was impressed with the volume of logs taken from this property. The Village received \$3,500.00 in the sale of these logs. On another note, the Christmas trees that were planted last year are not doing that well. The deer population in that area have been a major factor in this. He said that some of the trees need to be pruned and this is the time of the year to do it. He said that he will do the work for a nominal fee. He will submit a proposal for the November monthly meeting.
- Trustee Williams reported that Locktoberfest will be held on Saturday, October 16th. This will be the fifth year of this event and there are many vendors at this year's event. It is being sponsored by the Canal Corporation, Erie Canal Trail and LARAC.
