## **PUBLIC HEARING**

1. SITE PLAN REVIEW –LAFONTAINE'S RAINBOW GROOMING 173 BROADWAY STREET TAX MAP NO. 171.5-2-2

CHAIRMAN ROCHE ASKED THE APPLICANTS IF THEY COULD GIVE AN OVERVIEW OF THEIR APPLICATION.

APPLICANT; WE WOULD LIKE TO OPEN A PET GROOMING BUSINESS FOR CATS AND DOGS. WE HAVE ALL OF OUR PERMITS AND INSURANCE.

CHAIRMAN ROCHE ASKED WHAT THEIR HOURS AND DAYS OF OPERATION WOULD BE.

APPLICANT: WE WILL OPERATE 5-6 DAYS PER WEEK AND WE WILL BE OPEN FROM 7 AM - 7 PM

CHAIRMAN ROCHE ASKED IF THEY WILL BE OPERATING BY APPOINTMENT ONLY OR WILL THEY HAVE WALK IN APPOINTMENTS AS WELL.

APPLICANT: WE WILL ALLOW WALK IN'S FOR SMALLER JOBS LIKE NAIL CUTTING

CHAIRMAN ROCHE STATED HE NEEDED A MOTION TO REFER TO COUNTY AND SET A PUBLIC HEARING FOR FEBRUARY.

A MOTION TO ACCEPT THE APPLICATION, REFER TO COUNTY AND SET A PUBLIC HEARING WAS MADE BY JAMES BROOKS, SECONDED BY BERNIE TAYLOR.

CHAIRMAN ROCHE REMINDED THE APPLICANTS TO BRING A PICTURE OF THE SIGN (LOGO) AND DETAILS OF LIGHTING IN THE FRONT OF THE STORE.

DAVE ARMANDO FILLED IN THE BOARD AS TO UPCOMING THINGS FOR THE VILLAGE. 117 BROADWAY IS INTERESTED IN CONVERTING THE LOWER LEVEL OF BUILDING FOR OFFICE SPACE FOR A REAL ESTATE COMPANY AND UPPER-LEVEL APARTMENTS WITH A ROOF TOP USAGE. SHOULD BE SEEING AN APPLICATION SOON, HOPEFULLY.
