# RESOLUTION INTRODUCING PROPOSED LOCAL LAW AMENDING CHAPTER 313 OF THE CODE OF THE VILLAGE OF FORT EDWARD TITLED 'VEHICLES AND TRAFFIC'

WHEREAS, the Board of Trustees of the Village of Fort Edward has authority to regulate parking and vehicular traffic in the Village boundaries pursuant to the Village Law and Vehicle and Traffic Law of the State of New York; and

WHEREAS, the Board has pursued the relocation of the stopping point within the bounds of Broadway/New York State Route 4 at the intersection with East Street and Terminal Lane, for southbound traffic on Broadway/New York State Route 4, to a point northerly of the intersection of Terminal Lane and Broadway/New York State Route 4 such that vehicles would not be queued directly in front of said intersection with Terminal Lane as is the case now; and

WHEREAS NYS DOT has advised that to accomplish the above, Terminal Lane would need to be a "one-way" street; and

**WHEREAS**, to render Terminal Lane a one-way Street, the Board of Trustees believes, would require a portion of Satterlee Lane to similarly be a "one-way" street, and a local law has been drafted to accomplish this; and

WHEREAS the Village Board wishes to introduce and hold a public hearing concerning the proposed local law.

#### NOW, THEREFORE BE IT

**RESOLVED**, that the proposed local law designated Terminal Lane, Terminal Road and a portion of Satterlee Lane as "one-way" streets and therefore amending Chapter 313 of the Code of the Village of Fort Edward is hereby accepted for introduction to the Village Board; and be it further

**RESOLVED**, that the consideration and proposed adoption of this Local Law is an action under the New York State Environmental Quality Review Act (SEQRA). The Village Board hereby declares that this action is a Type II action pursuant to 6 NYCRR 617.5(33) and the action is hereby precluded from further environmental review: and be it further

**RESOLVED**, that a public hearing shall be scheduled for the consideration of this proposed local law to be held by the Village Board on May 2, 2022, at \_\_\_\_\_ p.m. at the Village of Fort Edward Village Hall; and be it further

**RESOLVED**, that the Village Clerk is direct to post and publish a notice of said public hearing in the \_\_\_\_\_ at least five (5) days before the public hearing.

#### OTHER BUSINESS

- Dan Boucher mentioned that the lights at the Little League Park have been replaced every year. The Fort Edward Fire Department replaces the bulbs as a training exercise. The heads of the lights are not working and need to be replaced. National Grid is offering a program which may help with the replacement of these. There will be no charge in the wiring, just replacing the heads. The Little League needs permission from the Village to forward past bills (pre-Covid) to them. National Grid would cover 50% of the costs if all the requirements are met. The Village would need three bids to see what the actual costs would be after the 50% match is applied. Since this is Village property, we should be able to use some of the ARPA money to help with this project.
- We received a letter from the Fort Edward Free Library requesting a donation to help with some of the much-needed repairs to the building. It was mentioned that the library should qualify for the CARES act which should help with this. We will check to see if they have applied for this grant.
- The deadline for submitting a proposed plan on how the ARPA funds will be allocated is April 30, 2022. We will submit a plan detailing how and where the money will be used. Mullen Park, the parking lot next to the old One More Grill, and the Fort Edward Little League

Park are some areas that are under consideration.

- We have received signs from the Glens Falls Hospital through a grant sponsored by the Department of Health., We will be placing yield signs throughout the Village. There will be a solar powered sign which will be placed on Broadway across from the Fort Edward High School. A kiosk will be placed near the train station which will highlight local businesses and public restrooms which would be of importance to the people using the bike trail.
- Village Attorney Matt Fuller reported that the sale of Church Street to Irving Tissue should be finalized by the end of the month or the beginning of May.
