<u>FROM THE MAY 16, 2017 MEETING MINUTES</u>: THE APPLICANT HAS SUBMITTED AN APPLICATION TO OPEN A PIZZERIA SHOP AT THE ABOVE STATED LOCATION. THE PROPOSED EXTERIOR CHANGES ARE AS FOLLOWS: ADDING A SIGN TO THE FACE OF THE BUILDING, PAINT THE SILVER WINDOW FRAMES BLACK, PUTTING GRAPHICS IN THE WINDOWS, ADD HORNS ON THE FRONT DOOR, AND REMOVE THE WHITE PAINT OFF THE BRINK.

A motion to open the public hearing was made by J. Brooks, seconded by J. Carroll. All ayes. Motion carried. There being no questions from the public, the board moved to discuss the application. J. Brooks asked the applicant if the paint had been tested for lead. The applicant stated that the paint had been tested and the results showed lead in the paint. As of now, the applicant stated that she isn't sure how she is going to address this. She is deciding between resurfacing with a thin brick or repainting. A discussion was held.

SEQR, Unlisted Action

Attorney Stockwell lead the board through Part II of the SEQR. A motion was made by J. Carroll, seconded by J. Brooks declaring the Fort Edward Planning Board as lead agent and that based on the information and analysis of the Board, and all supporting documentation the proposed Type II action will not result in any significant adverse environmental impacts and adopted a Negative Declaration as it relates to SEQRA. There being no written or public comments, a motion to close the public hearing was made by J. Carroll, seconded by J. Brooks. All ayes. Motion carried.

There being no further business, a motion to accept the **Site Plan Review** application from **Ann Stumvoll** for property located at **165 Broadway** based on the below listed conditions relative to the Board's discussion was made by **J. Conditions are as follows:

- ✓ The exterior of the building will be a neutral color.
- ✓ The exterior of the building will either be resurfaced using a brick covered façade, repainted or restored to its original brick. Any work relative to the exterior of the building will be done following NYS code, specifically as it pertains to the proper handling of lead paint.
- ✓ The hours of operation will be Tuesday-Thursday 11:00-9:00, Friday-Saturday 11:00-10:00 and Sunday 12:00-8:00. Closed on Mondays.
- ✓ In twelve (12) months, if work as approved thru the Site Plan Review (SPR) process is uncomplete, applicant may apply for an extension as allowed by SPR local law.
