WHEREAS, the Board of Trustees has studied the continuance of the position of village justice of the Village of Fort Edward; and

WHEREAS, the Board of Trustees has arrived at the difficult decision to consider abolishing the position of village justice of the Village of Fort Edward pursuant to New York Village Law §3-301(2)(a); and

WHEREAS, pursuant to New York Village Law §3-301(2)(a), to abolish the position of village justice of the Village of Fort Edward, a local law subject to permissive referendum must be adopted; and

WHEREAS, a draft local law abolishing the position of village justice of the Village of Fort Edward effective upon the expiration of the current term of village justice on March 31, 2025 pursuant to New York Village Law §3-301(2)(a) has been drafted, and the Board of Trustees scheduled a public hearing on the proposed abolishment of the position of village justice of the Village of Fort Edward to be effective March 31, 2025; and

WHEREAS, notice of said public hearing was duly posted and then published in *The Post Star*, the official newspaper of the Village of Fort Edward pursuant to and in conformance with Section 20 of the Municipal Home Rule Law and the Village Law; and

WHEREAS, said public hearing was duly held and all parties in attendance were permitted an opportunity to speak concerning the proposed local law.
